

**THE REGULATION OF THE SOCIAL CAMPAIGN
“HELP THE POOR ELDERS. DONATE 1 LEU”**

The object of the campaign:

Fund raising for helping the pensioners who represent a social risk because they have low incomes, serious health problems and they live alone, with no help from their families.

Organizers: The National Federation of the Mutual Help Centers of Pensioners “Omenia”

Media partners: The partnerships will be established after negotiation

The campaign period: First stage – 01.07.2010 – 31.12.2010

Regulation:

For making a transparent dispensation of the money collected during the campaign “Help the poor elders. Donate 1 leu!”, we establish the following rules:

1. Will receive an allowance of 50 lei (aprox 12 Euro), the pensioners who had a pension of 600 lei (130 Euro) or less on the date of the Government's austerity measures. The pensioners selected after this criterion should also live alone, have no other income and because of the medical problems they have prescriptions for medicines that costs more than 50 lei per month.
2. Every pensioner association of the National Federation of C.A.R.P. Omenia from Romania will appoint a three-member commission to analyze and establish which are the persons that meet the conditions to receive financial help mentioned at point 1. This commission will individually process each social investigation of the pensioners requesting with documents the non-refundable financial aid. The commissions can also include members of civil society and local authorities and they will assess the social investigations of the pensioners who apply for 50 lei allowances.
3. The 50 lei allowances will be offered just one time for each person either on the occasion of “The National Day of The Elders” or Christmas.
4. The 50 lei allowance is tax free.

5. The nominal list, based on the standards of the Federation, containing the persons to receive the non-refundable financial aid, included in the “Help the poor elders, Donate 1 leu” campaign, will be posted in easy access places and will be at all time visible. A copy of this list, signed by the members of the commission, will be sent to the National Federation of C.A.R.P. from Romania and will be posted on <http://www.fn-omenia.ro>.
6. The money collected during the campaign will be shared out to the Mutual Help Centers of Pensioners from the country proportional with the number of members.
